WHAT HAS HAPPENED SINCE THE LAST EDITION



<u>National Museum of the American Indian:</u> On April 10th, 27 Symphony Villagers arrived under sun-drenched blue skies at the National Museum of the American Indian. The building is a striking work of art on Independence Ave. at 4th St. in Washington.

The first stop for several people was the Rasmuson Theater. Excerpts from the play, "Stone Heart," depicted the travels of Lewis and Clark with their Indian guide, Sacajawea. Many in our group returned later in the day to enjoy the full 90 minute production. Others visited some of the permanent exhibitions such as *Our Lives*, which examines the identities of Native peoples in the 21st century and how those identities, both individual and communal, are shaped by deliberate choices made in challenging circumstances. Another popular permanent exhibition was *Our Peoples*, which explores events that shaped the lives and outlook of Native peoples from 1491 to the present. Additional films and works of art caught the attention of small groups making their way through this stunning structure.

The buzz on the bus coming home, however, was all about The Mitsitam (Let's Eat!) café. What a treat it was to sample Native foods found throughout the Western Hemisphere, including the Northern Woodlands, South America, the Northwest Coast, Meso America, and the Great Plains. Each food station depicted regional lifeways related to cooking techniques, ingredients, and flavors found in both traditional and contemporary dishes.

<u>Lunch Bunch at Kentmoor</u>: The April Lunch Bunch carpooled from the Clubhouse to Kentmoor on the Bay. The word is that men particularly enjoyed the menu: ham, turkey, deviled eggs, pasta and cucumber salads. The dessert table was outstanding. We thank Nancy Cotter and Marlene Tennier for organizing these fabulous meals, and Nancy thanks the many folks who willingly pitch in and clean up.

Community Meeting Notes:

- The SVBCC Community Meeting held on April 27, 2006, at 7 p.m. in the Clubhouse was well-attended. So many issues were addressed that the frequency of these meetings will be increased to once a month instead of six times a year. Minutes will be available on our community web site, which will be operational very soon.
- Delmarva Power has rejected our request to landscape electrical boxes. Denison is looking into uniform landscaping around the boxes that will grow back easily if it is damaged by Delmarva. We are looking toward a uniform approach so we can proceed as a community on this issue.

- Bag worms have been spotted already. The optimal time to spray is in June and Denison will spray at that time. Denison has also been advised that we need a day of sprinkler testing, perhaps a Saturday, when residents are home and can see whether their sprinklers are working properly. We will also receive a mowing schedule so owners will know what to expect, and can close windows before leaving home on mowing days.
- An American flag will be purchased and installed in the Grand Concert Hall.
- Capt. Aaron Sadusky, who is a Queen Anne's High School Graduate and West Point Grad, is now stationed in Iraq. Paul Sheehan is collecting donations for phone cards for Capt. Sadusky and his troops. Paul is at 146 Harmony Way, or call him at 410-758-4567 and he will come pick up donations.
- An SBVCC Board opening was created by the resignation of Vice-President Michael Teague. In addition, a newly created Finance Committee and a newly created Architectural Review Committee must be fully staffed. Everyone in attendance was invited to volunteer for these positions.
- The awning proposal has been completed and is in the hands of the developer. Once approved, the standards for awnings will be written.
- Blinds are on order for the Grand Concert Hall and the Billiards Room.
- Kevin Sullivan addressed issues concerning driveway extensions, the
 walkway behind Overture, the pond behind Sonata, and warranties. In
 addition, the rules with respect to the indoor pool and exercise facilities
 will be revisited.

FROM HOA/SVBCC

Exterior Modifications: Spring is here and Summer fast approaching, which means, "Oh I want to get outside and plant something, or let's install a screen door"! This is a reminder that any exterior modifications including, but not limited to, patios, decks, a tree, or extended flower beds, and extended driveways must be approved by the Covenants Committee before work commences. All work must be performed by a pre-approved subcontractor. Exterior Modification forms can be picked up at the Clubhouse from Jan, as well as a list of approved trees and plants for Symphony Village. (Determined by the County)

Please be as thorough as possible completing the form. Include a diagram of your project, signature(s) of your neighbor(s) and a copy of your property plat. The plat should be part of your settlement papers. Sketch the project on the plat itself in addition to the diagram of your patio or flower garden. The homeowners signature is on the back of the form - don't miss it. The more complete the form and necessary diagrams, the quicker Legum and Norman (to whom you send the completed form) will get your request to the Covenants Committee for final approval. ADKINS ARBORETUM is a 400 acre native garden and preserve promoting the appreciation and



conservation of the Delmarva Peninsula's native plants. It is adjacent to Tuckahoe State Park on Tuckahoe Creek near the town of Ridgely, just twenty minutes from Symphony Village. Four miles of paths wind across streams, through native meadows, and under the deep shade of a rich bottomland forest. The Arboretum sponsors programs in horticulture, ecology, and art for all ages. The Visitor's Center has wonderful array of

nature related gifts, an extensive library and book store, nature and art exhibits, and a plant sales area.

You can experience the beauty of nature at Adkins through regularly scheduled activities: journal writing through nature, soup'n'walks, movie fests, garden design classes, and an introduction to botanical art.

FROM THE KITCHEN OF ... PAT KINDLE

Mandarin Orange Salad

Depending on the number of servings you want:

A bag of Romaine, Spinach, or Trio salad mix

½ cup of slivered almonds or walnuts if preferred

1/4 cup of crumbled feta cheese

1 small – med size can of mandarin oranges drained

1/4 cup craisins

Approximately ¼ cup of Kraft Creamy Poppy Seed dressing

Toss first five items together in salad bowl, add the Poppy Seed dressing, tossing with the salad. Do not use too much dressing or it will make the salad too moist. For most groups you need to double the recipe.
