## **House Tour**



Symphony Village was full of excitement on April 28 as we experienced our 2<sup>nd</sup> House Tour. Everyone thoroughly enjoyed the beautiful homes and the delicious luncheon. The Clubhouse was ablaze with flowers and delightful music. A total of 245 House Tour tickets and \$900 in

raffle tickets were sold with 41 advertisers listing in our House Tour Brochure. The net funds amounted to nearly \$9,000. Two quick disbursements have been made. The first, a check for \$300, was delivered to Arlyn Marshall, winner of the raffle. The second, a check for \$527, the balance of our raffle funds, was payable to Hospice of Queen Anne's County. During the next couple of months, budget meetings will be held to determine the disposition of the balance of the proceeds. The number of volunteers working to produce this wonderful event was overwhelming and the feeling of camaraderie was everywhere. The Outreach Committee sends a huge *Thank You* to each and every one who so graciously gave of their time and talents to make the tour the wonderful success that it was. ### **Caregivers' Support Group**

A thank you letter to the Caregivers' Support Group from Nicki and Bob Offerman: "After living with us for almost 5 years, my mother's health has declined to the point where it has become necessary to place her in an assisted living environment. This difficult transition is exacerbated by being newcomers to Maryland and not knowing where to go or even what questions to ask. We found the Caregivers' Group here in Symphony Village an invaluable source of information, experience, and support. The information they have shared about assisted living, nursing homes, hospice, and services for the elderly has helped us provide proper care for my mother while with us and became key in making the critical decisions during the transition to assisted living. We've now plotted a detailed course that we're confident in--impossible without the Caregivers' Group. We can't say

enough about this marvelous group of individuals. Almost everyone has something to share and all leave with useful (and often surprising) information--no pressure. All personal experiences are kept confidential and remain within the group."

#### **Life After Cancer...**

"I survived Cancer!" How many of us can say that? There are 9 million cancer survivors in the U.S. today, and they can say with pride and humility they faced the devastating "C" word armed only with their faith and the support of family and friends. - how to find answers to questions regarding doctors, treatment, side effects, etc.

#### **Volunteer in Action**

"Assisting" is the "Goal" of Lacrosse Volunteer, Arlyn Marshall by Jon Briggs



A novice who wants to learn about the game of lacrosse could grab some books at the public library, Google the Internet, or take a stroll over to Arlyn Marshall's house. Sharing his vast knowledge and expertise of the game with players, coaches, and fans has been, and continues to be, a lifelong passion for this Symphony Village resident.

Arlyn took up the game of lacrosse for the first time in his sophomore year

at Southern High School in Baltimore. He must have been a quick study because in his senior year, Arlyn was named second team All State. That success led to a scholarship to attend Johns Hopkins University, the "Mecca" of college lacrosse at that time. In his senior year, he was named to the first team All American squad as a midfielder. After graduating from Hopkins, Arlyn continued his love affair with lacrosse, playing eleven years with several of the more prestigious lacrosse clubs in the Baltimore area. After hanging up his stick and cleats, Arlyn then turned to coaching where his success continued as:

- Head coach in twelve United States Club Lacrosse Association Championship games, winning seven titles between 1972 and 1992.
- Head Coach of Team USA in the Lacrosse World Games in 1990. His undefeated team won the World Team title.
- Only lacrosse coach to coach both the US National Team and the Canadian National Team.
- Compiled a career coaching record of 291 wins and 53 losses for an 85% winning record!
- Elected to the Maryland Lacrosse Club Hall of Fame in 1985 and the United States Lacrosse National Hall of Fame in 1990.

Arlyn loves to volunteer, and he likes to win, too, but he gets a great sense of satisfaction from seeing a player, who's been struggling for a long time trying to master a particular aspect of the game, and finally, through his hard work, doing it. Arlyn also enjoys taking a group of men, or kids, and molding 30-35 players into a cohesive and successful unit. He says, "I truly loved playing lacrosse when I was younger, but once I started coaching, there was no comparison. Coaching leaves a bigger imprint on more than just oneself."

Currently Arlyn is helping out with the Queen Anne's County High School boys' lacrosse team here in Centreville. He acts mainly as a consultant, interacting with the two other coaches and providing input whenever he sees the opportunity. "This has been one of my most enjoyable coaching experiences. We've got a great bunch of kids with the right attitude who are working very hard," he says. "It's so rewarding to see how much they've improved and it shows in their performance. So far this year they have 10 wins and only one loss."

Arlyn sums up his attitude about volunteering when he says, "I've always been a big believer in trying to better myself while assisting others to the best of my abilities. Volunteering has provided me with the opportunity to give something back to the community." His is the well-stated heart of volunteerism.

The grandchildren are visiting! What is there to see and do in Queen Anne's County?

- 1. Visit "Our Chesapeake Legacy" at the Chesapeake Exploration Center. It's like a museumbut it's not. The display is an interactive hands-on exhibit designed to make learning about our region both fun and memorable for all ages. This is something for everyone! The exhibit explores man's close relationship with the Bay and how that relationship has shaped our culture and history--and conversely--how we have shaped the environment of the Bay. Interactive computer and video stations provide more chances to discover the rich heritage of the Chesapeake Bay. Located on the waterfront at the Kent Narrows, the Center is just off Route 50/301 and the Cross Island Trail. Open daily from 10 a.m.-4 p.m..
- 2. Up for a little easy biking? No bikes? Call Happy Trail for your entire bicycle needs (410-643-0670). Try the **Cross Island Trail** that crosses Kent Island from Terrapin Nature Park on the Chesapeake Bay to the Chesapeake Exploration Center. While in Terrapin Park, walk along the sandy beach with a view of the Chesapeake Bay Bridge.



- 3. **Shore Fun Mini-Golf:** Offers great affordable family entertainment on an exciting 18-hole miniature golf course. Come aboard and play around waterfalls, bridge holes and the famous ship-wrecked boat. Rt. 50 to Exit 37, Rt. 8 south, 1 mile on left. (410-604-0555)

#### RECIPE OF THE MONTH

#### **Best in the West Beans**

350 Degrees, one hour – 10 to 12 servings

(1/2) pound ground beef

10 bacon slices, chopped

(1/2) cup onion, chopped

(1/3) cup packed brown sugar

(1/3) cup granulated sugar

(1/4) cup ketchup

(1/4) cup Kraft barbecue sauce

2 Tablespoons Kraft prepared mustard

2 Tablespoons molasses

(1/2) teaspoon salt

(1/2) teaspoon chili powder

(1/2) teaspoon pepper

16-ounce can kidney beans, drained

16-ounce can pork and beans

16 ounce can butter beans

(drain butter beans if using crock pot)

Brown meats. Drain; add onion and cook until tender. Combine and add to meat mixture: sugars, ketchup, barbecue sauce, mustard, molasses and seasonings; mix well. Add beans and pour into a 3-quart casserole. Bake. (If using crock pot, put mixture in crock pot and heat on medium until ready to eat.)
