MUSINGS FROM THE BOARD

A few words about the budget process—soon the various committees will start putting together their recommendations for what their needs are and what they would like to have done next year. By the end of August, they should be submitting their requests to management. Landscaping and irrigation contracts account for 35% of this year's budget; both expire this year. Thus, next year we will have new contracts for both. The Operations Committee will work with management to secure bids and then pass recommendations on to the Board for approval. Management will consolidate these requests along with the fixed expenses (such as salaries, electricity, gas, etc.) and pass them on to the Budget and Finance Committee for their review before forwarding to the Board. The Board will then release the draft budget to the community for comments before it is voted on by the Board at the December annual meeting.

The Board of Directors of Symphony Village has approved the Architectural Guidelines for Solar Panels (Appendix H). There is also a new Modification Request Form that is to be used **ONLY** for solar panels. A copy of these documents is on the Bulletin Board at the Clubhouse and on the SV Website. This new solar panel request form is to be used starting June 9. If you turn in the wrong form with your solar panel information, you will be asked to fill out the correct form prior to the next committee meeting. GAZEBO GARDEN CLUB and VICTORY GARDEN – Jack Hennessey







READING FOR FUN BOOK CLUB – Jack Hennessey



The book for our June 17 meeting is *Call Me Zelda*, by Erika Robuck, who also authored *Hemingway's Girl*, one of our previous “top ten books.” Erika visited us in the past; but she cannot attend this meeting because she is extremely busy, having completed her fourth novel recently. *Call Me Zelda* is the story of Scott and Zelda Fitzgerald, the king and queen of the Jazz Age, who seemed to float on champagne bubbles above the mundane cares of the world. In fact, their endless parties were only a distraction from their inner turmoil and from a love that united them with a scorching intensity. Zelda was committed to a Baltimore psychiatric clinic in 1932, vacillating between lucidity and madness in her struggle to forge an identity separate from her husband. The story is related through the eyes of Anna Howard, a psychiatric nurse, a friend and confidante, of Zelda. Anna feels that Zelda may be the true genius of the two Fitzgeralds. The story is based on facts; but, of course, the narrative is cleverly generated by the author, based on thorough historical research. All residents are invited to attend our June meeting to share in the lively discussions and to enjoy light refreshments provided by Pat Kindle, who recommended this book.

The book for our July 15 meeting is *The Husband's Secret*, by Liane Moriarty, recommended by Pat Loiacono.

Upcoming presentations:



“NO LEFT TURNS”

This is a wonderful piece by Michael Gartner, a newspaper editor and past president of NBC News. In 1997, Gartner won the Pulitzer Prize for editorial writing. The story is well worth reading, and a few good chuckles are guaranteed.

My father never drove a car. Well, that's not quite right. I should say I never saw him drive a car. He quit driving in 1927, when he was 25 years old, and the last car he drove was a 1926 Whippet. "In those days," (he told me this when he was in his 90s) "to drive a car you had to do things with your hands and feet and look every which way—so I decided you could walk through life and enjoy it or drive through life and miss it." At which point my mother, a sometimes salty Irishwoman, chimed in: "Oh, bull shit! He hit a horse." "Well," my father said, "there was that, too." So my brother and I grew up in a household without a car. The neighbors all had cars, but we had none. My father, a newspaperman in Des Moines, would take the streetcar to work and often walk the 3 miles home. If he took the streetcar home, my mother and brother and I would walk the 3 blocks to the streetcar stop, meet him, and walk home together. My brother, David, was born in 1935, and I was born in 1938; and sometimes at dinner we'd ask how come all the neighbors had cars but we had none. "No one in the family drives," my mother would explain, and that was that. But, sometimes, my father would say, "But as soon as one of you boys turns 16, we'll get one." It was as if he wasn't sure which one of us would turn 16 first. Sure enough, my brother turned 16 before I did, so in 1951 my parents bought a used 1950 Chevrolet from a friend. It was a four-door, white model, stick shift, fender skirts, loaded with everything; and, since my parents didn't drive, it more or less became my brother's car. Having a car but not being able to drive didn't bother my father, but it didn't make sense to my mother. So in 1952, when she was 43 years old, she asked a friend to teach her to drive. She learned in a nearby cemetery, the place where I learned to drive the following year and where, a generation later, I took my two children to practice driving. The cemetery probably was my father's idea. I remember him saying, "Who can your mother hurt in the cemetery?" For the next 45 years or so, until she was 90, my mother was the driver in the family. Neither she nor my father had any sense of direction so he loaded up on maps (though they seldom left the city limits), and he appointed himself navigator. It seemed to work. Still, they both continued to walk a lot. My mother was a devout Catholic, and my father was an equally devout agnostic—an arrangement that didn't seem to bother either of them through their 75 years of marriage. Yes, 75 years, and they were deeply in love the entire time. My father retired when he was 70, and nearly every morning for the next 20 some years, he would walk with mom the mile to St. Augustin's Church. She would walk down and sit in the front pew, and he would wait in the back until he saw which of the parish's two priests was on duty that morning. If it was the pastor, my father would go out and take a two-mile walk, meeting my mother at the end of the service and walking her home. If it was the assistant pastor, he'd take just a one-mile walk and then head back to the church. He called the priests "Father Fast" and "Father Slow." After he retired, my father almost always accompanied my mother whenever she drove anywhere, even if he had no reason to go along. If she were

going to the beauty parlor, he'd sit in the car and read, or go take a stroll or, if it was summer, have my mother keep the engine running so he could listen to the Cubs game on the radio. In the evening, when I'd stop by, he'd explain: "The Cubs lost again. The millionaire on second base made a bad throw to the millionaire on first base, so the multimillionaire on third base scored." If my mother went to the grocery store, he would go along to carry the bags out—and to make sure she loaded up on ice cream.

As I said, my father was always the navigator; and, when he was 95 and my mother was 88 and still driving, he said to me: **"Do you want to know the secret of a long life?"** (I couldn't wait for the answer, knowing it would probably be something bizarre.) **"No left turns,"** he said. "What?" I asked. "No left turns," he repeated. "Several years ago, your mother and I read an article that said most accidents that old people are in happen when they turn left in front of oncoming traffic. As you get older, your eyesight worsens, and you can lose your depth perception, it said. So your mother and I decided never again to make a left turn. Think about it—3 rights are the same as a left, and that's a lot safer. So we always make 3 rights." "You're kidding," I said, turning to my mother for support. "No, your father is right. We make 3 rights. It works." But then she added: "Except when your father loses count." I was driving at the time and almost drove off the road as I started laughing. "Loses count?" "Yes," my father admitted, "that sometimes happens; but it's not a problem. You just make 7 rights, and you're okay again." "Do you ever go for 11?" I asked. "No, if we miss it at 7, we just come home and call it a bad day. Besides, nothing in life is so important it can't be put off another day or another week."

My mother was never in an accident, but one evening she handed me her car keys and said she had decided to quit driving. That was in 1999, when she was 90. She lived 4 more years, until 2003. My father died the next year, at 102. They both died in the bungalow they had moved into in 1937 and bought a few years later for \$3,000. Sixty years later, my brother and I paid \$8,000 to have a shower put in the tiny bathroom—the house had never had one. My father would have died then and there if he knew the shower cost nearly three times what he paid for the house. He continued to walk daily. When he was 101, he had me get him a treadmill because he was afraid he'd fall on the icy sidewalks but wanted to keep exercising. My father admitted that the first 100 years were a lot easier than the second, but he was of sound mind and sound body until the moment he died. One September afternoon in 2004, my father and my son went for a drive with me. It was clear to all 3 of us that my father was wearing out, though we had the usual wide-ranging conversation about politics and newspapers and things in the news. At one point my father said, "You know, I'm probably not going to live much longer." "You're probably right," I said. "Why would you say that!?" He countered, somewhat irritated. "Because you're 102 years old," I answered. "Yes," he said, "you're right." He stayed in bed all the next day. That night, I suggested to my son and daughter that we sit up with him through the night. He appreciated our being with him; however, at one point, apparently seeing us look gloomy, he said: "I would like to make an announcement. No one in this room is dead yet." An hour or so later, my father spoke his last words: "I want you to know that I am in no pain. I am very comfortable, and I have had as happy a life as anyone on this earth could ever have." A short time later, he died. I miss him a lot and I think about him a lot. I've wondered now and then how it was that my family and I were so lucky that he lived so long. **I can't figure out if it was because he walked through life – or because he quit taking left turns.**

RECIPE OF THE MONTH

SCALLOPS AND ANGEL HAIR PASTA

From the kitchen of Joan Hennessey

½ cup hot water	1 pound bay scallops, drained
¼ cup chopped, dried tomatoes	1 cup half and half
1 small onion, chopped	¼ teaspoon salt
1 small green pepper, chopped	¼ teaspoon dried crushed red pepper (opt.)
1 small red pepper, chopped	8 oz. angel hair pasta, cooked
2 garlic cloves, minced	½ cup grated Parmesan cheese (opt.)
2 tablespoons olive oil	



Pour ½ cup hot water over tomatoes. Let stand 10 minutes or until softened. Drain and set aside. Sauté onion and garlic in hot oil in a large skillet over medium heat until tender. Add tomatoes and bell peppers; sauté 3 to 4 more minutes or until tender. Reduce heat to low; stir in scallops, salt, half and half, and crushed red pepper. Cook, stirring often, 2 to 3 minutes or until scallops are opaque. Toss together scallop mixture and pasta. Sprinkle with Parmesan if desired...Serves 4.
