## I. GARBAGE

- 1. Household garbage is collected on Wednesdays.
- 2. All garbage cans must be placed at the curb on Wednesday by 6 a.m. but no earlier than Tuesday.
- 3. All garbage placed at curbside for collection must be in garbage bags in a trash can with the lid secured.
- 4. A maximum of 6 garbage cans will be picked up per billing unit. Garbage cans may be a 50-96 gallon capacity not to exceed 96 gallons.

## II. RECYCLING

Recycling is collected on Wednesdays. Place items out by 6:00 a.m. Please separate from household garbage. Do not place recycled items in a bag. The Town has provided a 32-gallon recycle cart per household that will remain the property of the Town and is only to be used for recycling. Queen Anne's County also provides recycling igloos on Banjo Lane behind the Health Department.

### Items to recycle:

- 1. Glass jars and bottles. (rinsed)
- 2. Plastic jugs and bottles. (rinsed)
- 3. Aluminum and steel cans. (rinsed)
- 4. Corrugated cardboard and paperboard boxes flatten and bundle. (no pizza or food boxes) Food products are no longer allowed as recycle.
- 5. Office paper, newspapers, phone books, papers, paperback books, magazines, catalogs, cards, mail.

## Items that are not recyclable:

- 1. Plastic bags, plastic lids, or towels.
- 2. Ceramics, window glass, Pyrex, light bulbs, plates, drinking glasses, or vases.
- 3. Scrap metal or frozen food containers.
- 4. Hazardous or bio-hazardous waste.
- 5. Styrofoam.

## YARD WASTE

Trees, limbs or branches should be placed curbside (not in the roadway) by 6:00 a.m. Mondays. Yard Waste pick-up will not occur during mid-December, January, February, and mid-March.

Branches may not be longer than 3 feet. Logs longer than 3 feet do not need to be tied but bundled. Logs and bundles of branches may not weigh more than 40 pounds.

Leaves and grass clippings shall be in baskets, cans, or containers, which shall not exceed 40 lbs. They shall not be placed in gutters nor streets. A maximum amount collected will be 10 bags.

## <u>IV. BULK ITEMS / WASTE</u> <u>APPLIANCES, TIRES</u>

Bulk items, appliances and tires should be disposed of at the Queen Anne's County Transfer Station located at 401 Harper Road, Centreville; Monday, Wednesday and Saturday, 8am – 4pm. Questions can be directed to the Department of Public Works Solid Waste Division at 410-758-2697.

Construction debris from building renovation or repair work, shall be removed by the contractor, builder, or property owner. Transfer Sites do not accept construction debris.

## VII. HAZARDOUS WASTE

For the next event location for household hazardous waste, electronics recycling, and latex paint recycling contact the Maryland Environmental Service by calling 1-800-473-2925.

## **PARKING METERS**

Metered parking spaces are free at this time on a trial basis.

## SIDEWALKS AND YARDS

Centreville's Code requires that property owners maintain yards and sidewalks as follows:

- 1. Property within town shall be kept free of weeds, grass, and/or other unhealthy vegetative growth that exceeds 12 inches in height.
- 2. Sidewalks shall be kept in good repair in accordance with town standards.
- 3. Property owners shall keep sidewalks free of weeds, trash, debris, snow, and ice.

There shall be no burning of leaves, garbage, or other rubbish within town limits.

## SNOW REMOVAL

Below is the priority listing of how the Town of Centreville staff responds to snow events. The purpose of this procedure is to provide clear expectations to the community, about the process and priorities governing the Town's snow removal process.

The Department of Public Works shall salt, plow, and otherwise maintain public roadways in the following prioritized order:

1) Clear major arterial and connector streets so emergency vehicles can pass (e.g. police, fire, ambulance, etc.)

2) Minimize accumulations on other streets so at least one lane is passable.

3) Once 1 and 2 have been achieved, perform maintenance work to improve conditions generally. This may involve snow hauling, expanding the drive aisles (e.g. eventually from curb to curb), additional salting, clearing fire hydrants for emergency access, clearing storm drains to move snowmelt and therefore avoid water ponding and freezing, clearing the municipal parking lot and metered parking so the community can shop for necessities, sustain the commercial core, go to court, pay bills, etc.
