#### **BOARD ACTION ITEMS JANUARY 2021**

**PAT FOX, PRESIDENT**

The following unanimous electronic votes were taken by the SV Board of Directors since December 4, 2020. These email votes will be ratified at the February 5, 2021 meeting and entered into the Board meeting minutes.

- Unanimously approved a motion on January 2, 2021, to allow a resident to install seven bluebird nesting houses along the north side of Pond 1 in the SV common area. They will be placed in the tall grass of the non-mowed area adjacent to the forest preservation area and Pond 1. The resident will be responsible for all expenses, installation, and maintenance of the nesting houses. In the event the

resident can no longer maintain these boxes, and unless another resident(s) agree to pick up the responsibility, the boxes and poles must be removed at originator's expense.

- Unanimously approved a motion on January 5, 2021 to hire OneScapes Landscaping for \$550 to remove fallen trees which are causing a damming of floating debris and diverting the stream leading to erosion and damage to the slope below Opera Court homes.
- Unanimously approved a motion on January 7, 2021 to have Anchor Aquatics, the SV pool maintenance company, order and install a new spa heating unit at the cost of \$12,180.
- Unanimously approved a motion on January 12, 2021 to make changes to the Interim Rules and Regulations for Use of the Clubhouse, Pools/Spa and Amenities requiring:
  - Face coverings to be worn while working out in the SV fitness center at all times
  - Face coverings to be worn on the indoor pool deck at all times. Face coverings are not required to be worn in the water
  - Residents are asked to limit use of fitness center equipment to 30 minutes when others are waiting.

#### Covenants Information From 2019 Architectural Requirements

“To retain the beauty and the architectural integrity of the community, the Covenants Committee will evaluate applications for exterior modifications using both subjective and objective criteria. Each application will be evaluated individually and many factors will be considered including visual impact, neighbor privacy, lot size, and configuration. The architectural review process has been established to maintain the integrity of the architectural design character of Symphony Village. To this end, the Covenants Committee will review all proposed additions, improvements, or alterations on houses for conformity with the architectural requirements. Article IX of the declaration sets forth provisions with respect to the review process.”

#### Here come the 17-year cicadas – what you need to know!

Do you recall when the cicadas were here last? For those who guessed 2004, you’re right! Well, it’s time again for the influx of billions and billions of cicadas! This year’s 17-year batch is being called Brood X. Brood X never really left us; instead, they’ve been waiting underground. When the soil 8” beneath the ground reaches 64° Fahrenheit and there’s a nice, warm rain, their emergence will often be triggered. Symphony Village should anticipate seeing them in May;

however, depending on the temperature, they may begin emerging in late April or early June.

Contrary to popular opinion, adult cicadas *do not* cause serious tree or plant damage from their feeding activities. The adults only live two to three weeks. And cicadas do not prey on other insects, nor are they likely to [bite](#) a person. They also do not suck blood, do not transmit any known diseases to people or animals, and do not possess the type of mouthparts that enable them to consume plants in your vegetable or flower gardens. So, for Heaven’s sake— don’t grab the insecticide! No need to waste your money and chance harming the environment! Instead, use this opportunity to listen to the males as they call the females for some tumbling fun in the trees, if you know what I mean. Or wait! Better yet, let’s do as Aristotle wrote, *“The larva of the cicada on attaining full size in the ground becomes a nymph; then it tastes best, before the husk is broken. At first the males are better to eat, but after copulation the females, which are then full of white eggs.”* Yes, folks we will soon have a treat that will not be available for another 17 years!

Cicadas are a gluten free protein and a rich treat that can be prepared in many ways. In Maryland, the tradition is to deep fry them until they float to the top. Then, scoop them out onto some paper towels (we don’t want too much grease) and sprinkle with Old Bay. Wow! Delectable! Many Marylanders say they taste like soft shell crabs with asparagus. In Jersey, they are known as “shrimp of the land” and the Department of Agriculture

hails them as a good fat, high in calcium, iron, and zinc. Try them toasted with garlic, topped with salt and lime. and served with Oaxacan cheese and pickled jalapeños. So, don't just sit around this summer and be annoyed by this insect's mating calls (AKA: incessant noise). Grab a pot, experiment a little, and enjoy some yummy cicadas. They're free! Bon appetite, everyone! Oh yes, make sure you cook a cicada and not a locust. Don't know the difference? Well that's for another article.

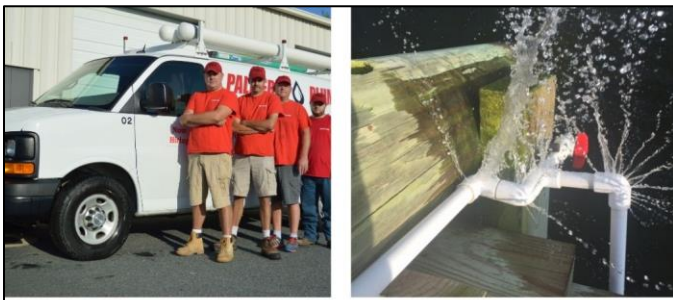

**SNEAKERS 2020 YEAR IN REVIEW**

The year 2020 was an unusual year for everyone, and those of us who work with Sneakers were a part of that. While we held no meetings, we still managed to communicate and accomplish some tasks. E-mail, texting, and telephone calls were our primary forms of communication. Although there were no formal fundraising activities, we did receive donations, both directed and non-specific, which we used for several purposes. While we did not work directly with our children, we provided assistance as we were able. The local backpack program needed funds, so we provided donations for them. When a local school needed Chromebooks for some pre-K students, Symphony Village residents contributed generously to provide several devices. During the late fall and early winter, our Santa Tree program was exceptionally well supported with both gifts and generous financial donations. We “adopted” 12 families initially, which grew to 14 after emergency appeals from the schools we support, and included over 35 children. In looking back, it is incredible to consider what Sneakers was able to accomplish in a very challenging year.

Hopefully, with the vaccines reaching more and more people, it will soon be possible for schools to get back to safe in-person teaching. While we will probably not be able to be in the schools the remainder of this school year, we will be looking for new and different ways to provide support to them.

These drills will help your hand/eye/ball coordination and it is good practice to prepare for spring play.

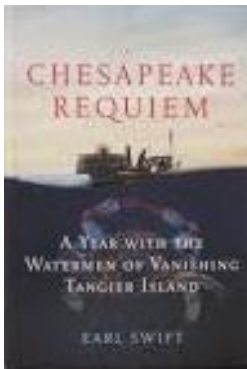
- Take your paddle and a ball and hit the ball up in the air LIGHTLY as many times as you can without it hitting the ground.

## READING FOR FUN – DECEMBER 2020 REVIEW

The SV Book Club met virtually on December 15 to discuss *Chesapeake Requiem, A Year with the Watermen of Vanishing Tangier Island* by Earl Swift. Beaming in on Zoom were: Joe Sikes, Jan Withers, Bob Nilsson, Jim & Kathryn Buckheit, Sue Goldberg, JoAnn Walker, Peggy Decker, Cathy Olson, DeAnn Cheyne, Diane Briggs, and Mary Jo Volpicelli.

Tangier Island is near the Maryland/Virginia state line and can be reached by ferry from Crisfield, Maryland. The Book Club chose the book to learn more about a unique crabbing community in Maryland, both historically and in our current events. It also offers an intriguing field trip possibility when the weather is warmer, and Mr. Vaccine rescues us from the Corona monster. The author, Earl Swift, spent two years researching and living

among the watermen of the island.

Tangier Island faces an existential threat of disappearing into the Chesapeake Bay. In 2015, a study conducted by the Army Corps of Engineers, using maps dating to 1850, concluded that the island had shrunk from 2,163 acres to 789 acres since then. The study projected that the island would be lucky to survive for another 50 years. Mayor Ooker Eskridge sees this as a result of erosion and focuses on trying to get funding for seawalls and replacement of eroded sections of the island. The author points out that a combination of sea level rise, subsidence, and erosion work together to cause the loss, but what the islanders see is the erosion.

The island was first settled in 1788 and the islanders that are described in the story are almost all descendants of this very insulated society. Many go back seven or eight generations and are concerned about lack of a younger generation to follow them. The current population of 481 is down from 604 in 2000. The local high school class of 2020 only had one member. The main economy of the island changed from oysters to crabs in the early 20<sup>th</sup> century and it remains so to the present. But it is demanding work and the author provides firsthand stories from residents about challenges faced as they go about their daily lives.

In 1807, Thomas Crockett attended a Methodist camp meeting on the Eastern Shore and was so impressed with the enthusiastic worship that he organized meetings on Tangier Island. These annual meetings became a staple of early Methodism in Maryland and the island's two churches remain Methodist today.

During the War of 1812, Admiral George Cockburn used the island as a base of operations for the British fleet. In 1814, he launched the invasion of Washington from Tangier Island and returned after burning the U.S. Capitol. The ease of the victory caused him to launch an attack on Baltimore but, as F. Scott Key wrote, "The flag was still there!" Unfortunately, this early victory of Baltimore over a team from England has been difficult to repeat in recent years when contests involve teams from New England.

Generally, the Book Club learned many interesting facts in **Chesapeake Requiem**, but the detail and repetition made the book a challenging read. Many of the club members, myself included, were unable to complete the book. While the author's writing was appreciated, the amount of detail was somewhat overwhelming and gave it the feel of reference book to some degree. The club graded the book at 6.7 out of 10.

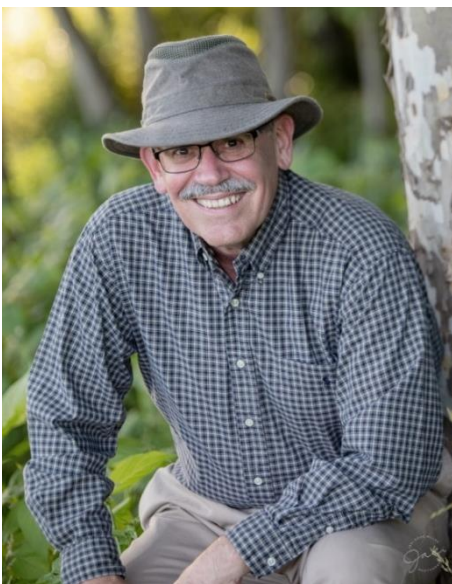

Happy New Year!! 2021 – Year of Hope and Kindness

I hope everyone is having a safe and healthy start to 2021 and had an enjoyable Christmas and Holiday season. I hope everyone had an opportunity to go to "downtown" Centreville and see and enjoy the Christmas and Holiday Season decorations and the beautiful Christmas Tree. Again, thanks to the Town of Centreville Operations, Kip Matthews and his crew, and then the Legacy Foundation, "Joy of Light" Festival, with Murdoch Florist and many volunteers who have helped to decorate the town for the holidays! In this time of pandemic, it is so wonderful to see everyone come together to start the celebration of the Holiday Season.



The Town Council of Centreville and the Centreville Park Advisory Board would like to thank all groups who participated in this year's Christmas Tree Decorating Contest. Lawyers Row looked fantastic, and we thank you for your time and participation. We would like to recognize these groups for their tremendous effort: Girl Scout Troop 414, Wye River Upper School, Girl Scout Troop 219, Girl Scout Troop 946, Ravens Roost #142, Girl Scout Troop 446, Girl Scout Troop 591, Day Care, Inc., and Girl Scout Troop 1271.

Also, congratulations are in order for the *NEW Town of Centreville Police Officer, Christopher Tyler Clagett*. He is a very experienced police officer coming to work in his hometown after having served with the Easton, Maryland police department. Welcome, Officer Clagett.

**Seven new business actions** were also introduced at the December 17, 2020, meeting:

- FY2020 Audit - the audit results showed no discrepancies.
- 6-month Budget Update was reviewed for Revisit Budget Items (primarily of operational in nature; totaling \$77,692), which passed unanimously.
- Resolution 11-2020; Permit/Development Review Fees – The new fee structure was updated for the first time in almost 20 years, which the Town Staff had been working on for a few years.
- Ordinance 11-2020; Text Amendment: Museums in the R-2 Zoning (First Reading) with second reading at the January 7<sup>th</sup> meeting.
- Resolution 13-2020; Charter Amendment: Town Council Member Vacancy
- Presentation on Centreville Police Department Restructuring Request by Chief Joseph Saboury:
  - Facility/Police Department Building;
  - Salary Comparison (to enable Centreville Police Department to retain and compete for personnel with surrounding allied law enforcement agencies);
  - Retirement (complete an actuary study for Law Enforcement Officers' Pension System); and
  - Reorganize Police Department by removing existing part-time Parking District Enforcement Officer and adding a full-time Administrative Assistant
- Lumec Bollard Lights for the Centreville Wharf Dock were approved (cost of \$11,172).

**HR Director reported** that FY 2020/21 revenues were better than expected growth and the Council approved a one-time bonus of \$1,200 and a cost-of-living increase (COLA) of 1% of salary or \$500.00, whichever is greater for the Centreville employees.

**Director of Public Works reported** that fiber optics were being installed in the Northbrook community; that final paving in Northbrook community was completed; and that individual citizens can report a street outage directly to Delmarva Power on-line. 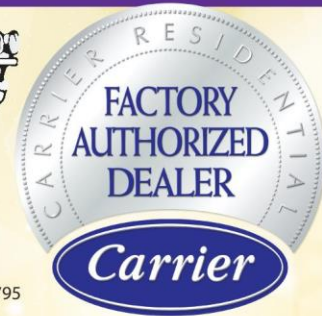
