2022 SV HOA BOD

President's Annual Summary - 2022

2022 HAS BEEN A SUCCESSFUL YEAR ALL IN ALL. We finally completed revisions of the SV governing Documents after a four-year effort that stalled along the way. These documents have been filed with the appropriate agencies as defined by law. While they are accessible on our SV Website, we will be mailing hard copies for your personal files.

We also hired ProCom as our property manager. They have been handling our financial work—dues receipt, bill paying, budget tracking since 2017, which remains as part of their tasks. Rebecca, Julia, and Nick are now employees of ProCom. It has been beneficial to go to Scott Davis, the owner with over 20 years' experience with the company that also manages over 60 other MD HOAs, and be able to ask, "What do other HOAs do in this situation?" Previously, it often meant going to our costly attorney for answers.

From an infrastructure standpoint, we resurfaced the tennis/pickleball courts; resurfaced the interior of the outdoor pool, replaced various pool equipment that failed, such as the spa heater, replaced irrigation equipment that failed, and replaced the indoor pool door to the parking lot. We also have set up the new memorial garden in the patio adjacent to the pavilion by adding a wind-driven metal sculpture to the large resin pot and planted perennials there. Dead trees were removed and replaced where prudent. Trees and shrubs were treated for where necessary pests. We now have new procedures for trees and landscaping. For trees, Bartlett Tree inspects areas of SV every two weeks tracking pest seasons and diseases, etc., and deals with any problem during the inspection. This regular inspection process has saved us \$6,000 this year. For landscaping, Level Green recently started mowing our lawns and common areas over the course of four days versus all in one day. The intent is to improve the quality of the service including slowing down and avoiding ruts and other damage. If there is a problem, they are onsite four days a week whereby they can respond to the complaint. The new Board and management will continue to monitor this in 2023.

There are many other maintenance items that the BOD and staff has addressed. This information can be obtained on our Website from the detailed Management Reports prepared by Rebecca Wagner as well as all past Board packets and minutes.

There are some areas where it isn't such great news. As you know, we are looking at an assessment increase for the first time in nine years, where we have consistently paid \$230 per month. Due to inflation, supply chain difficulties, ability of vendors to attract labor, etc., most of our regular service contracts costs have increased significantly for 2023—an average of 14%. On top of this, the State passed a law requiring a greater contribution to our Reserve Fund. Even though SV has a comfortable margin, we need to generate additional moneys for this fund. This change was precipitated by the disastrous Condo collapse in Florida a few years ago due to deferred maintenance. While we are a single-family home HOA, the same legislative concern about adequate replacement coverage has spread across the United States. As a result, we are dealing with not only increased service costs, but also the need to make a larger annual contribution to reserves. We recommended a 13% increase of \$30, which amounts to a \$260 monthly assessment. A May 2022 state law allows us to increase our dues above our 10% threshold identified in our governing document to meet this contribution requirement. Still, to meet the reserve requirement, we will have to take some funds from our rainy day and unobligated cash funds.

The Board, Committees, and management work hard to develop a proposed budget for an upcoming year. Of course, a budget is a plan—you don't know what the new year will bring. In 2022, we overran our snow removal budget by almost \$37,000, and our legal fees by nearly \$26,000. While the legal docs are finished, and a good proportion of that total expenditure was for that effort, we also had complaints that needed to be addressed by our lawyer. A resident filed a written complaint to the state attorney general about our closed work sessions that two different firms of attorneys, who are experts in HOA law, said we were OK in doing. This complaint cost the HOA \$7,550 in 2022—so one quarter of the overrun.

There are other items that we had hoped to complete in 2022 but must continue into the new year. For instance, SV is attempting to recover nearly \$14,000 paid to the town of Centreville in 2017 to enable receiving a construction permit for the expansion project. The town charged us these funds to cover any increased water usage, known as an EDU or Equivalent Daily Usage, despite SV being fully built out (no new houses), and we don't rent the Concert Hall outsiders. We have been tracking our water use over time since the project was completed, but Covid interrupted what can be defined as reasonable data from the town's perspective. Their latest Clubhouse fulltime use threshold is calendar year 2022. At the beginning of April, 2023, the Board will evaluate the 2022 last quarter water usage invoice and determine if during the calendar year we remained at or under three EDUs. SV will then apply to receive the funds. If we go over the three EDUs even a sliver, they will round up to four so we would be out of luck.

We have heard nothing lately from the town about their water meter reader program that would result in a flagpole and antenna mounted in the Symphony Way traffic circle. Our newly elected council person, Jim Beauchamp, had proposed that the project be delayed until other options could be evaluated; however, there was not a majority of the town council in support. Our Board told the town we want a written agreement outlining rights and responsibilities of each party signed by each party for our protection.

Regarding the Cannabis operation in town—while Green Thumb Incorporated recently admitted their plants smell when budding in September and October, even at the end of November, there was a strong odor. As an aside, I smelled a strong odor on December 6 in my front yard. I told the 2023 Board that I am tracking this, working with two town council people, which I will report to them about. With the recent passage of legalization of cannabis starting next July, we must be careful that their operation does not expand without some boundaries and controls. As another aside, the group I am working with is tracking these odors. If you notice this strong skunky odor, please send me a short email with the date, time, and your address.

This is my last meeting after six years on the Board. I've enjoyed serving this community and welcome the new board members who will replace Pat Ways and me. I thank the current BOD members for all their hard work—especially their agreeing to work consistently to finish and close out the updating of the governing documents.

HOA BOARD OF DIRECTORS HIGHLIGHTS - DECEMBER 2022 DEBI WELLS, HOA BOD SECRETARY

Thank you to all who made time to attend HOA meetings this year. If you were not available to attend the December meeting, the highlights are below. Please note, this article is to update residents on HOA Board decisions, it does not replace the higher level of detail (contract specifics, etc.) found in HOA meeting minutes and other documents on the community's website.

Email Board Approval: There was one urgent email vote ratified by the Board since the October 21 HOA meeting. It was to replace additional sidewalk blocks last month while the contractor was on-site. This was a time-sensitive matter since fast approaching winter weather would prohibit the work this year. (This November 16 motion and approval for sidewalk replacements authorized approximately \$1.4K for the additional sidewalk work in addition to a \$2.5K contingency for any unexpected expenses. These amounts were added to the October 21 HOA meeting approval of \$25K for sidewalk replacements.)

December HOA Meeting – Board Votes: The following projects and/or activities for the community were voted upon at the December 7, 2022, HOA meeting:

Landscape Maintenance Contract for 2023: Level Green submitted a one-year contract to continue turf management (mowing operations across multiple days), edging, trimming, fertilizer applications, weed control, soil tests, insect control, aeration, overseeding, spring clean-up, mulch, leaf removal, and more; the detailed contract is available on the Symphony Village Website). After a review by the Landscape & Irrigation (L&I) Committee and the Board, this contract was approved for ~\$283K.

Irrigation Pump 2 Variable Flow Drive (VFD) Replacement: L&I recommended this pump be replaced/purchased this year. It will be installed by Eagle Pump and Montgomery Irrigation in Spring 2023.

Currently, the existing pump erroneously emits on-going alarms that often frequently turns the pump off, which impacted half of the community. The Board approved this pump replacement from Reserve Funds for under \$7.2K.

Amended Governing Documents Mailer: The HOA is required to distribute the recorded HOA documents to all residents following the approval of the amendments earlier this year. While the documents are available on the community's Website, access is different than distribution. By law, distribution is required. Two options to send this mailer were possible: (1) mail to all 395 homeowners at a cost not-to-exceed \$3.5K; or (2) mail only to non-registered homeowners to the ProCom portal (164) that can send an electronic distribution and email to remaining homeowners electronically at a cost not-to-exceed \$1.7K. The Board approved the first option to ensure the legal requirement was met.

Lease Addendum: An Addendum To Lease form was approved by the Board to support Article 8.7 of the 2022 approved HOA governing documents. Highlighted in the Addendum are Articles 8.1, 8.2, 8.3, and 8.5 of the Declaration of Covenants, Conditions and Restrictions.

2023 Budget: The 2023 budget, as presented, was approved by Board. Included in the 2023 budget is an increase in the HOA monthly assessment. Starting January 1, 2023, the HOA fee will be increased from \$230/month to \$260/month.

Effective October 1, 2022, "The governing body of a homeowners association has the authority to increase an assessment levied to cover the reserve funding amount required under § 11B-112.3 of this title (MD Code, Real. Prop. § 11B-117), notwithstanding any provision of the declaration, articles of incorporation, or bylaws restricting assessment increases or capping the assessment that may be levied in a fiscal year."

CFG, TAB, and TIAA Bank CDs: CFG (an online bank firm based in New Jersey), TAB (Transportation Alliance Bank), and TIAA (Teachers Insurance & Annuity Association) each have a Symphony Village Certificate of Deposit (CD) maturing between mid-December and mid-January. The Budget & Finance (B&F) Committee recommended the Association liquidate these CDs and reinvest with Fidelity Investments with a return rate of 4%. Additionally, some funds are earmarked as Reserve Funds. Details are within the December 7 Reference Materials online.

Queenstown Bank Money Market (MM): B&F recommended closing the MM (\$35,067) at Queenstown Bank (at .1%) and opening a MM with Congressional Bank (at 2%) to gain more interest.

The Institute for Adult Learning (IAL) is a non-profit organization whose mission is to provide learning experiences and social events that enrich the lives of the age 50+ community in the Mid-Shore area. The IAL will host a Showcase of Classes for the Spring 2023 Semester on Saturday, January 7, 2023, from 2–4pm, at the Kennard Center, 410 Little Kidwell Avenue, Centreville, MD. OPERATIONS COMMITTEE

JOE SIKES, CHAIR; FRED KURST, VICE CHAIR

The Operations Committee is responsible for aiding the HOA Board of Directors and the General Manager regarding management and operation of community common property. We share this responsibility with the Landscape and Irrigation Committee and focus on things such as the Clubhouse, swimming pools, and sidewalks.

The Operations Committee finished up the year with the largest replacement of sidewalks in SV history. Second Wind Contracting replaced more than 1,000 sq. ft. of concrete. For the first time, this work included cutting of tree roots that caused much of the sidewalk upheaval. By consulting with Bartlett Tree specialists, we discovered that cutting the roots does not endanger the trees if done properly. This will allow the community to switch from the shaving strategy of recent years to full replacement.

Particular credit goes to Charles Levay and Mike Norris for surveying the community since last May and reviewing additional requests when the work started. The Operations Committee inspects the sidewalks annually and starts with work requests submitted by residents. We expect more sidewalk replacement in the future.

The Operations Committee is currently reviewing the Replacement Reserve Study due to be revised in 2023. A subcommittee of Fred Kurst, Dominic Mancinelli, Norm Bossie, Nancy Emerick, and me is reviewing all 231 capital assets listed in our current study. The review focuses on when replacements are expected to be necessary

and what the replacement cost will be. A new Maryland law requires a specific contribution to the Replacement Reserve account each year, which somewhat reduces our flexibility when constructing annual budgets. Our review is focused on improving the accuracy of the FY2023 study.

We are always looking for new members to help ensure our community remains one of the most attractive neighborhoods on the Eastern Shore. Our first meeting will be held on Thursday, January 19, 2023, at 10 a.m. in the Clubhouse. Residents will also be able to attend virtually.

SYMPHONY SNEAKERS LINDA FARRAR

READING FOR FUN - NOVEMBER 2022 REVIEW

The SV Book Club held a hybrid meeting on November 15 to discuss *Something Unbelievable* by Maria Kuznetsova. Attendees included: Joe Sikes, Jan Withers, Kathryn & Jim Buckheit, Sue Goldberg, Cathy Olson, Carol Saltiel, Kitty Wilson, and Bob Nilsson. Mary Jo Volpicelli could not attend but provided comment separately.

Maria Kuznetsova was born in Kyiv, Ukraine, and moved to the United States as a child. She has fashioned a story about the struggles of Natasha Schulman, who is a new mother and aspiring actress in modern day Manhattan. Trapped between the demands of motherhood and a failing career, Natasha seeks refuge in video calls with her grandmother Larissa, who lives in Kyiv. I admit that the Ukrainian connection attracted our attention as a Book Club. Let's see how that worked out.

Natasha also immigrated as a child from Ukraine and the opening chapter informs us that by the time she was seventeen, she had lost her father, mother, and first husband. Larissa bemoans that America has made Natasha soft and cites her proclivity to bring all manner of scroungy pets into the home. Larissa also describes how when she visited from Ukraine, she would reduce the pet population by taking them out back with a frying pan. Alrighty then!

Natasha's acting career is strongly influenced by her ability to speak Russian and her roles often consist of playing Russian prostitutes (including on "The Americans"), This is frustrating and her attempt to seek better

roles is hamstrung by the demands of taking care of baby Talia. She seeks escape in listening to her grandmother's grim tales of survival during World War II. It seems their families, going back four generations, had survived the Communist revolution and, subsequently were forced into a work camp when the Nazis invaded Ukraine. Much of the book describes the starvation and death experienced by the family and how they survived.

The story attempts to demonstrate that the two women are not so different in their life struggles, and Natasha even becomes motivated to write a one-woman play based on her grandmother's story. The club had two impediments in following this story line. First Larissa's story was very grim, whereas Natasha's situation is better described as sad. We felt that the comparison was very unbalanced. Secondly, while Larissa can be described as a no-bullshit person (remember the frying pan), Natasha comes across mostly as a whiner. Despite recognizing that Natasha's behavior could have been a result of post-partum depression, her character was just unlikeable. The book club overwhelming found Natasha to be their least favorite character.

The book was written well before the current invasion of Ukraine. This left us to imagine how the story would have been written if Natasha's character was based in modern day Ukraine. But the Club graded the story as written and awarded a score of 6.0 out of 10.

The score might have been a point higher except for an incident related during the family's stay in a 1940s Nazi work camp. Starvation was an ever-present threat and one day the family cat mysteriously disappeared. When meat soon appeared on the dinner table, suspicion was strong that the meal was procured with a frying pan! The club's grade clearly reflected a cat penalty.

We hold our meetings on the third Tuesday of each month at 7 p.m. in the Clubhouse. We have started to hold hybrid meetings, so contact me if you would like to attend virtually. My email is sikes.withers@yahoo.com
