### **BOARD HIGHLIGHTS – SEPTEMBER**

**BILL RIDGWAY, BOARD PRESIDENT**

You have probably noticed our repaved Clubhouse parking lots. They are the result of great planning by our Operations Committee, who prepared the RFP requirements, recommended a paving proposal and worked with General Manager and the contractor to make sure the work went as planned. Thanks for your efforts on this!

Look for the next big project this fall—replacement of sidewalk blocks that have been pushed up or broken by tree roots. All SV sidewalks have been surveyed, with white paint marks indicating sidewalk sections due for replacement. There will be an opportunity to tell Rebecca of additional damaged sections that you feel should be included.

The Board is also working with Landscape and Irrigation to upgrade pump controls and water pressure management at three pump stations starting this fall. The goal is to protect the infrastructure from pressure or flow anomalies or software control flaws.

**The notes that follow discuss business conducted or reported at our last Board Meeting on September 7. Please note that this log is not an official record. Minutes must be approved by the Board at a future meeting and will then be posted on our Website.**

**Treadmill Purchase:** The Board voted by email on August 21 to authorize replacement of two out-of-service gym treadmills with new ones at a cost of \$9963.

**EDU Reimbursement:** The Board met on September 1 with Town Manager Chip Koogle and Program Project Manager Jenial Turner to discuss our request to have the Clubhouse Expansion EDU fee refunded. We were pleased that Mr. Koogle expects to recommend to the Town Council that the EDU fee be refunded.

**Flagpole Water Meter Agreement:** The Town confirmed that there is no new information on an installation date as they have not completed their contracting process. We'll continue to coordinate with them on landscaping plans and other aspects of the project.

**Sidewalk Replacement:** The Board approved the proposal from Second Wind Contracting to replace 2,844 sq. ft. of concrete sidewalk for a price of \$66,288, not to exceed \$75,000 for necessary additional work. The replacement includes cutting of tree roots where necessary and would be paid with Reserve funds.

**Fitness Center Ceiling:** The Board passed a motion approving HVAC ductwork re-insulation (\$2,065) and hot water line repair (\$1,115). Work is expected to proceed as appropriate after Erie Insurance approves ceiling restoration claim.

**2023-2024 Snow Removal Contract:** The Board approved a 2024 snow removal contract with Chester River Landscaping.

**2024 Fitness Equipment PM Contract:** The Board also approved a 2024 Routine Maintenance Service Agreement with RMS Fitness Equipment Services for Four Quarterly Visits totaling \$1400.

**2024 Ash Tree Soil Treatments:** The Board passed a motion to accept the proposal from Bartlett Tree Experts for two nutrient treatments of ash trees using Fortiphite and Boost Liquid in 2024 at a cost of \$3,648

**Tree Removal RFP:** The Board authorized the L&I committee to develop requirements for Management to seek proposals from additional vendors for removal of dead or dying common area trees and for specific tree pruning.

**Irrigation Pump Upgrades:** The Board approved a Montgomery Irrigation proposal to add well protection equipment at pumps 1–3 with a cost not to exceed \$30,000. The new equipment is planned to match that previously installed at pump 4. Approval was conditional on more detailed item-by-item pricing by LLC/Montgomery Irrigation and detailed warranty disclosures.

**October 2023 BOD Meeting Date:** The next Board Meeting will be held as planned on October 27 at 10 a.m. with participation possible in person or via Zoom.

**Saltwater Chlorination Pool Conversion:** The Board did NOT pass a motion to include \$35,000 in the 2024 Budget to convert the indoor pool to saltwater. Board members asked Management to seek firm quote(s) for the conversion and annual saltwater pool maintenance.

**Overture Way Berm & Retaining Wall Maintenance:** Management and Level Green Landscaping surveyed the liriopie plantings and advised that no additional work was needed at this time to keep the plantings healthy.

## COVENANTS CORNER

My goodness, this community has been very busy in 2023! There have been approximately 194 EMFs (Exterior Modification Forms) submitted in 2023. This is a record number for one year *and we're not done yet!* Projects include many roof replacements, patio installations, driveway extensions, flower bed enhancements, and other improvements. All that has enhanced our community in small and large ways!

I would like to commend the volunteer residents that helped to ensure a smooth EMF process from submission to vote approval. These volunteers fall into two groups. The first are all of you SV residents that have done an excellent job in referring to the SV Architectural Requirements (AR) before submitting your EMFs. This not only includes AR compliance regarding the actual work proposed, but the inclusion of all **required documentation with the EMF**, which always speeds up the overall process. The second group would be the members of the Covenants Committee (CC) which includes a very helpful HOA Management Team and Board of Directors Liaison. Because of so many EMFs submitted, all mentioned above have worked very hard each month to understand all the nuances that apply to each specific EMF. ***KUDOS TO ALL!***

So, let's finish strong as we enter the final quarter of 2023! Here are just a few reminders for those of you who may have some projects that have slid a bit to the end of the year:

Always go to the SV Website and refer to the Architectural Requirements (AR) to ensure that you understand the parameters of your project with regards to AR compliance.

If your project includes landscape and/or hardscape items, please always use due diligence regarding possible encountering of underground utility cables or irrigation lines and sprinkler heads. If so, then complete the Miss Utility Request form or a work order for Montgomery Irrigation to assist in locating the lines. Our HOA management team can assist with this item.

Carefully select your contractor.

Collect all required documentation before submitting the EMF. Documentation specifics are listed in the AR for each type of project topic.

Turn in your EMF to Julia at least seven days prior to the next CC meeting. Meetings are on the second Wednesday of each month.



*Cheerily* work with your CC member as he or she visits your residence to discuss your project.

The basics are; however, we all know that unexpected things arise. When they do, be assured that the CC will work with you regarding the completion of your project to make sure that your project is compliant with the AR requirements. Looking forward to working with you as we close out 2023.

## OPERATIONS

The Operations Committee is responsible for aiding the HOA Board of Directors (BOD) and the General Manager (GM) regarding management and operation of community common property. We share this responsibility with the Landscape and Irrigation Committee and focus on such things as the Clubhouse, swimming pools, and sidewalks.

The Operations Committee met on August 17 and recommended acceptance of a proposal from Second Wind Contracting who did our sidewalk replacements in 2022. We were pleased that the cost per square foot had not increased and have laid out replacements for more than twice as many blocks as last year. Charles Levay has toured the community with Second Wind and ensured blocks to be replaced are marked in white. Where appropriate, tree roots will be cut to protect against further damage. The BOD approved the contract on September 7. The GM will publish a schedule for work after consulting with Second Wind.

The committee has also been reviewing an updated draft of our Replacement Reserve Study from Miller Dodson. We plan to meet with the company and the GM to finalize our inputs in the next few weeks. We expect to make a recommendation to the BOD for acceptance at their October meeting.

Lastly, I would like to commend the GM, Fred Kurst, and Bob Eaves for their efforts in overseeing execution of the parking lot paving. The parking lot looks great and the work proceeded smoothly. Personally, I left for Oregon when they ripped up the old parking lot in case something went wrong. With those three in charge, I obviously had nothing to worry about.

The next Operations meeting will be held on **September 19 at 10 a.m.** in the Clubhouse. The meeting will be hybrid and all residents are welcome to attend either in person or virtually.

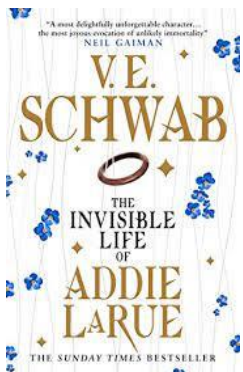

## READING FOR FUN – AUGUST 2023 REVIEW

The SV Book Club met on August 15 to discuss **The Invisible Life of Addie LaRue** by V.E. Schwab. Attendees included Joe Sikes, Jan Withers, JoAnn Walker, Bob Nilsson, Jim and Kathryn Buckheit, Sandy Allegra, Mary Jo Volpicelli, Judy Sutter, and Sue Goldberg. While unable to attend, some club members provided their scores separately. These included Cathy Olson, distinguished photographer Len Saltiel, and his equally distinguished wife Carol. Bob Nilsson asked that I point out that it is the field of photography in which Len has distinguished himself.

Normally when our book club gathers the room is abuzz with members recounting highlights of our book for the month. In this case, the room was abuzz with accusations of who suggested this book selection. I will not reveal the identity, but will limit myself to dropping hints. Alexander Hamilton famously bemoaned occasions when he was not "in the room where it happened," but suffice to say, in this case, it would have been a positive.

In defense of the book selection, let me say that author Schwab's premise was intriguing. Addie LaRue grew up in a small French village in the early 1600s and was being forced into a teenage marriage she abhorred. She ran

from the wedding altar and hid in the woods as all the villagers searched for her. In the dark of the forest night, she encountered the devil (Luc in our story, get it?) and made a deal to free her from the constraints of her life. She would be immortal; but when she tired of her new life, Luc would get her soul. In 20th century terms, the story is a mashup of *Runaway Bride*, *Othello*, and *Damn Yankees*. Sounds interesting, right?

In our story, the Luc has put some devilish constraints on Addie in exchange for her freedom and immortality. She cannot write or leave any memory of herself. Therefore, she immediately becomes unrecognized by her family and friends. Anyone she meets has no memory of her after leaving her presence. Accordingly, she can slip around unnoticed but she has no identity or home. As Janis Joplin sang, "Freedom's just another word for nothing left to lose!" The story jumps back and forth between 1630 and 2014, when Addie is more than 300 years old. She can only die if she surrenders her soul to Luc, who appears randomly through the years to encourage her to do so.

The story finds Addie moving around the planet, sometimes on her own initiative and sometime through Luc's interference. She survives revolutions and World Wars, while engaging in innumerable short term relationships often with the same partner. Once she knows how to appeal to someone, it becomes simple to rinse, wash, and repeat. Near the end of the story, she meets someone who does not forget her, offering the possibility of a long term relationship. However, he has his own deal with the devil which somehow negates parts of Addie's deal. While this is a confusing development, it offers hope for an end to the story. Hooray!

The chapters take two forms. Some describe her many relationships and how she manages within her constraints. The rest describe Luc's many visits over the years. Theirs is a love/hate relationship because Luc's physical manifestation is based on Addie's ideal boy when she was young. Even though she hates the devil for her circumstances, Luc still can charm her when he wants. He is, after all, her only long term interpersonal relationship.

The club awarded a score of 4.3 on our scale of 10, which is in the top third of our bottom three books. Even *Once Upon a River* scored higher. (This is inside Book Club humor.) I will confess that the lowest scored book on our list was one that I suggested, so I still hold that distinction. Before you ask, the book was *On Traigh Lar Beach* by Diane Beaff.

## 2023 BLUEBIRD NESTING SEASON RESULTS

The 2023 Bluebird nesting season ended in late August. It was a very productive summer. Thank you to everyone who participated in the Bluebird's fight for survival.

There are now 38 nest boxes in the yards of Symphony Village residents. There are an additional eight nest boxes around pond #1. Three nest boxes were used by Carolina chickadees, fledging 15 young. Three nest boxes were used by Carolina wrens, fledging 12 young. Four nest boxes were used by tree swallows, fledging 15 young. All three species are, like the eastern bluebird, welcome cavity nesters.

Altogether, we had 20 nesting pairs of bluebirds, who raised and fledged 85 bluebird young. Most bluebird nests contained four to five eggs and young. Some nest boxes had a second successful nesting of

bluebirds. Approximately 16 nest boxes were used by bluebirds.

As some reported during my last visits to the nest boxes, *it was* sad to see the bluebirds leave. However, it is only six short months (the end of February) before they return and the nest boxes will be reinstalled.

Let's go for 100 plus fledglings in 2024!

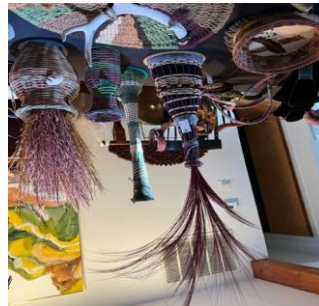
